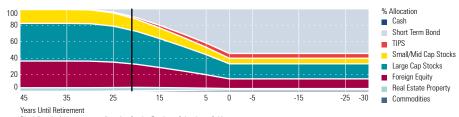
Volatility Analysis

Allocation of Assets



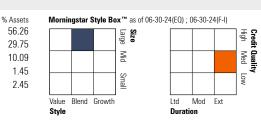
Black line designates target allocation for the Fund as of the date of this report.
